## Being the parent or guardian of the member

d) agree that my son/daughter shall participate in club activities without any liability whatsoever on the part of 1<sup>st</sup> Chard Wheelers, or any other club or organisation affiliated thereto or their officials or members in respect of any injury, loss or damage suffered by him/her, provided that this does not exclude the liability of any such party for death or personal injury arising from that party's negligence.
